PRIVATE FUNCTION AGREEMENT

This agreement is between Caffe Dolce Vita and _____ (name), for a private function to be held in the upper level of Caffe Dolce Vita on _____ (date) from _____ to _____ (time).

I understand that I am required to submit a deposit in the amount of \$100.00 to reserve the above requested date for my function. I understand that the deposit will be deducted from my bill upon final payment.

I understand that if I should cancel my reservation 30 days prior to my function, 50% of the \$100.00 deposit will be returned to me in the form of gift certificates or a credit towards another confirmed date. Cancellations within 29 days of the reservation date will result in forfeiture of the entire deposit.

I understand that I am **guaranteeing** a minimum of _____ people for my function. In the event that I have less guests than _____ I will be charged a "no-show" fee of \$20.00 plus gratuity for every person missing from the **minimum guarantee**.

In the event that my **final guarantee** is greater than my **minimum guarantee**, I will submit my **Final Guarantee Count** forty-eight (48) hours in advance of my event and that my final bill will reflect charges for the **final guaranty count**. I am aware that I will be charged a "no-show" fee of \$20.00 plus gratuity for every person missing from my **final guarantee count**.

I understand that the menu prices and service fees are subject to change and my final bill must be paid in full on the date of my event.

I understand that Caffe Dolce Vita must receive prior notification and give approval for any and all decorations, entertainment, demonstrations, presentations or exhibitions. Caffe Dolce Vita will comply with Rhode Island Fire Codes, as well as all Rhode Island state laws.

Caffe Dolce Vita complies with all Rhode Island state laws in regard to responsible service of alcohol beverages and strives to protect our guests, staff and establishment from liabilities due to alcohol service. Caffe Dolce Vita reserves the right to refuse or terminate liquor service to any person that appears intoxicated or in a near-intoxicated condition during any time of the event. Alcohol service will not be provided to any person under the age of twenty-one (even with "parental approval"). I understand that my event may be shut-down, with no refund given, if any minor is provided with alcohol from one of my guests.

Stipulations:

All functions will be placed on a 4hour schedule. If additional time is requested, based on availability, a fee of \$100 per hour will be charged. Caffe Dolce Vita must provide all food and non-alcoholic and all alcoholic beverages. In accordance to Rhode Island state law, alcoholic beverages may not be brought in or removed from premises. Caffe Dolce Vita complies with all Rhode Island state laws in regard to responsible service of alcohol.

Services and fees

A bartender is provided for a fee of \$50 for parties of \$25 or more.

We can provide a valet service, based on the final guarantee, for \$2 per guest

There is a \$1 charge per guest for cutting service of any cake not provide by Caffe Dolce Vita.
